Dear Parents/Carers

SCHOOL OPERATION COMMENCING

WEDNESDAY 6TH JANUARY 2021

Following the government's announcement of a full lock down school will only be open for children of key workers until at least February half term.

The most recent scientific advice on how to further limit the spread of COVID-19 remains clear. The government have requested these key principles are followed:

1. If it is at all possible for children to be at home safely, then they should be.
2. Parents should not rely for childcare on those 'who are advised to be in the stringent social distancing category'. This includes grandparents, friends, or family members with underlying conditions.
3. Parents should also do everything they can to ensure children are not mixing socially in a way which can continue to spread the virus. They should observe the same social distancing principles as adults.

The Government has requested that all schools provide **optional** attendance for education for a **limited number of children**. These are:

- Children who are vulnerable i.e., those who are:
 - Supported by Social Care
 - Children in Care – known as Looked After Children (LAC)
 - Young carers
 - Disabled Children
 - Or have an education, health and care plan (EHCP)
- Children whose parents are **critical to the Covid-19 response** and **cannot be safely cared for at home.**

All other children will need to stay at home, so we ask that you do not send your child into school. Remote learning, in line with government expectations, will be provided for all children not in school.



The government has also published an updated list of key workers which is attached to this letter. The guidance has also been revised to outline that this support is for children with **at least one parent or carer** who are identified as 'critical workers' by the government.

Please complete the attached proforma and return to the school office should you fall into the Key/Critical Worker category. **No space will be provided without completion of this form.**

I want to reiterate the key message about the closure plans: **Every child who can be accommodated at home should be.** We absolutely understand that families are worried about being able to work but these are extraordinary times and we are all having to make some very difficult decisions and sacrifices. However, with the challenges we face with our own staff and the national social distancing policy, we wish to minimise any risks and **the number of students attending should only be in circumstances where it is essential.** This may be contrary to some advice being given by other employers, but school will only be providing places if absolutely essential to key operations.

This remains an ever-changing situation and the position may well change again in the future. We will continue to update you as the need arises.

I wish to thank all our school staff, volunteers, governors and trustees who have helped to support with planning, and who will continue to do so over the coming months. The last-minute nature of decisions by government has meant staff have spent hours meeting, planning and agreeing procedures, only for everything to be discarded overnight.

However, I would like to thank you for your continued support and understanding during this period. Your recognition of our efforts, when there are staff at breaking point remains exceptional.

Definition of Key Workers

Parents whose work is critical to the Coronavirus (Covid-19) and EU transition response, including those who work in health and social care and in other key sectors outlined in the following sections.

Health and social care

This includes (but is not limited to); doctors, nurses, midwives, paramedics, social workers, care workers and other **frontline health and social care staff** including; volunteers, the support and specialist staff required to maintain the UK's health and social care sector, those working as part of the health and social care supply chain, including producers and distributors of medicines and medical/personal protective equipment.

Education and childcare



This includes; childcare, nursery and teaching staff, teaching assistants, support staff, social workers and **those specialist education professionals who must remain active during the COVID-19 response** to deliver this approach.

Key public services

This includes; those essential to the running of the justice system, religious staff, charities and workers **delivering key frontline services**. Those responsible for the management of the deceased, and journalists and broadcasters who are providing public service broadcasting are to be included.

Local and national government

This only includes those administrative occupations essential to the effective delivery of the COVID-19 response and the delivery of and response to EU transition or delivering essential public services such as the payment of benefits, and the certification or checking of goods for import and export (including animal products, animals, plants and food), including government agencies and arm's length bodies.

Food and other necessary goods

This includes those involved in food production, processing, distribution, sale and delivery, as well as **those essential to the provision** of other key goods (for example hygienic and veterinary medicines).

Public safety and national security

This includes police and support staff, Ministry of Defence civilians, contractor and armed forces personnel (those critical to the delivery of key defence and national security outputs and essential to the response to the COVID-19 pandemic and EU transition), fire and rescue service employees (including support staff), National Crime Agency staff, those maintaining border security, prison and probation staff and other national security roles, including those overseas.

Transport and Border

This includes those who will keep the air, water, road and rail passenger and freight transport modes operating during the COVID-19 response and EU transition, including those working on transport systems through which supply chains pass, and those constructing or supporting operation of critical transport and border infrastructure through which supply chains pass.

Utilities, communication and financial services

This includes staff needed for **essential financial services** provision (including but not limited to workers in banks, building societies and financial market infrastructure), the oil, gas, electricity and water sectors (including sewerage), information technology and data infrastructure sector and primary industry supplies to continue during the COVID-19 response, as well as key staff working in the civil nuclear, chemicals, telecommunications (including but not limited to network operations, field engineering, call centre staff, IT and data infrastructure, 999 and 111 critical services), postal services and delivery, payments providers and waste disposal sectors.
